



# Kentucky Absentee Voting



## Who can vote absentee

### **Voting absentee by mail: You must fulfill one of these qualifications in order to request a mailed absentee ballot:**

- You work outside the county and will be absent from the county all hours and all days that absentee voting by machine is conducted
- Due to advanced age, disability, illness or medical emergency;
- You are a member of the armed forces or the dependent of a member of the armed forces;
- You are military personnel confined to a military base on election day;
- You reside overseas but are still eligible to vote in Kentucky;
- You are a student attending school outside the county of your voter registration;
- You temporarily live outside the state but are still eligible to vote in Kentucky; or
- You are incarcerated in jail and have been charged but not convicted of a crime.

### **Voting absentee in person: You may vote an absentee ballot on a voting machine in the county clerk's office 12 or more business days before the general election on November 7, 2006 if you meet one of the following conditions:**

- You will be out of the county on election day;
- You are a pregnant woman in your third trimester;
- You are a member or an employee of the county board of elections, deputy clerk, alternate precinct officer or appointed to a precinct other than that in which you are registered;
- You are a member of the armed forces who will be confined to base within the county on election day and learns of that confinement within 7 days or less of the election;
- You are a student attending school outside the county of your voter registration who will be absent from the county on election day; or
- You or your spouse, who has surgery scheduled that will require hospitalization on election day.

## Key contacts

**Absentee ballot voting is managed by your county clerk. We have provided their contact information at the end of this document.**

## Vote by mail

**You must contact your county clerk's office to request an absentee ballot application. You may make the request by telephone, facsimile machine, by mail, or in person.** Note: if you registered to vote by mail and have not yet voted in person, contact your county clerk to determine if you can vote absentee by mail or if there are special identification requirements with your application.

### General Election (November 7, 2006)

**You can apply for a paper absentee ballot at anytime during the election year.** Your application must arrive at the county clerk's office on or **before October 31, 2006.** We recommend that you apply for your ballot no later than October 27, 2006 to allow enough time to process your application.

## Absentee in person

**If you are eligible, you may vote early in your county clerk's office.**

### General Election

**You may vote early from approximately October 20 through November 6, 2006 in your county clerk's office.**

Some counties allow you to vote more than 12 business days before the election. We recommend that you call your county clerk's office to find out when absentee voting in person begins in your county.

The voter is solely responsible for complying with any and all election laws and voting requirements.
